Claudine Armand is Senior Lecturer at Nancy II University. She teaches American Studies, mainly text and image analysis and twentieth century American art. She is particularly interested in the interrelationship between heterogeneous semiotic codes, namely the iconographic and the linguistic. Her doctorate thesis was about the American writer (poet and short story writer) and artist (engraver and collagist), Anne Ryan.
